FAS is working on the issue of setting tariffs for electricity transmission for territorial grid organizations (TGO) using the method of reference costs. In the future, a template for collecting information from such organizations will be determined to define the standards.

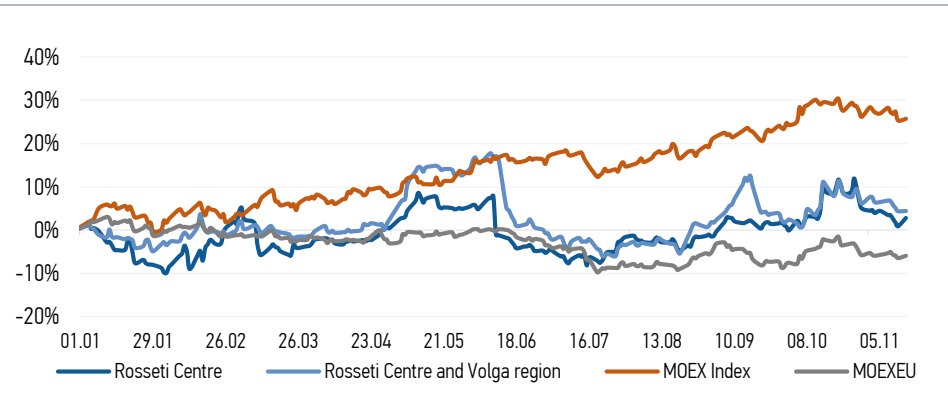
