The Ministry of Labour approved the updated professional standard "Operational and technological management worker in electric grids of 35 kV and above"

By Order N 607n dated 15 October 2025, the Russian Ministry of Labour approved the updated professional standard "Operational and technological management worker in electric grids of 35 kV and above". The document comes into force on 1 March 2026, and remains in effect until 1 March 2032. The purpose of these specialists' professional activities is the operational and technological management of electric grid systems of 35 kV and above within the operational responsibility of the grid organization.


