The Ministry of Energy proposed to modernize power grids through infrastructure loans

The Ministry of Energy of the Russian Federation proposes to consider the possibility of providing infrastructure loans for the modernization of power grids. This was stated by Deputy Energy Minister Evgeniy Grabchak during the round table "Project activities in the constituent entities of the Russian Federation", organized by the Federation Council. Grabchak drew attention to the fact that heating, water supply and sewerage networks have already been included in the program for the provision of infrastructure loans, while the main source of financing for the reconstruction of power grids is the tariff sources of natural monopolies.


