- PJSC Rosseti - Controlling entity of IDGC of Centre, PJSC, as another controlled entity of PJSC Rosseti (indirectly through IDGC of Centre, PJSC) – JSC "Sanatorium "Energetik", is a party to the deal with IDGC of Centre, PJSC; - Lyudmila Alexeevna Sklyarova - a member of the Management Board of IDGC of Centre, PJSC, as her son, Vladimir Sergeevich Sklyarov, holds the position of a member of the Board of Directors of JSC "Sanatorium "Energetik", which is a party to the deal with IDGC of Centre, PJSC.

Upon the transaction, to submit to the Board of Directors for consideration simultaneously with the report on the execution of the business plan of IDGC of Centre, PJSC for the year following the year of the transaction, a report on the actual achievement of the targets and effects of the transaction in accordance with the values specified in Appendix # 2 to this decision of the Board of Directors of the Company.

5.3. To ensure repayment of the loan, provided to JSC "Sanatorium "Energetik", until 31.12.2022.
