The Cabinet of Ministers approved the forced sale of shares of energy companies for the combination of energy sales activities with the activities of electricity transmission and Interregional Dispatching Office

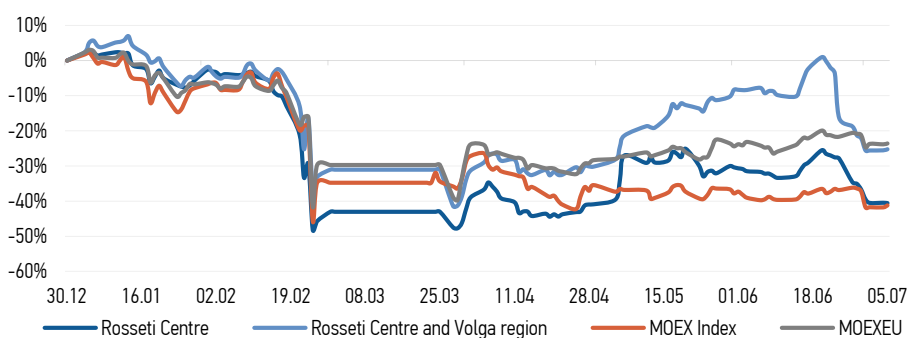
