Putin signed a law on expansion in 2022-2023 of powers of the government to regulate the fuel and energy complex and housing and communal services

Vladimir Putin signed a law giving the government the authority to establish in 2022-2023 temporary specifics for regulating relations in the electric power industry, gas, heat, water supply and sanitation. The document was adopted by the State Duma on 20 April and approved by the Federation Council on 26 April.

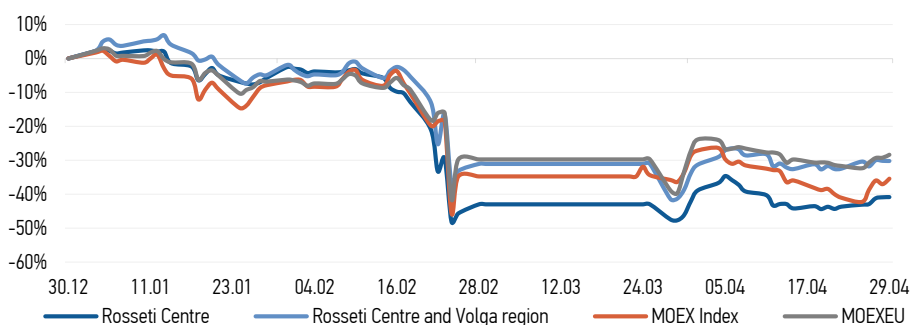
