A military helicopter cut off the ground wire of the power line in the Bryansk region

At 8.21 a.m., a line and a substation, which supply energy to more than 2,500 consumers, including four public facilities, were switched off in the electric networks of Klintsy. Presumably, a military helicopter cut off the ground wire of the power line and damaged the pole. Crews of power engineers transferred the supply of the consumers to the reserve circuit in 46 minutes and restored the supply of electricity at 09.07 a.m.


