# The Energy Committee presented proposals for finalizing the bill on systemically important territorial grid organizations

The State Duma Committee on Energy presented its proposals for finalizing the bill on backbone territorial grid organizations for the second reading. The bill envisages the creation in each region of systemically important TGOs (STGOs) – a single centre of responsibility that will perform the function of a "one-stop shop" for consumers of electricity transmission services and energy sales organizations, operate ownerless power grid facilities and eliminate large-scale failures in grids of other territorial grid organizations according to a decision of the regional reliability headquarters.

## The Kalugaenergo branch is reconstructing a line in the city of Medyn

As part of the implementation of the federal project "Formation of a Comfortable Urban Environment", power engineers dismantled an old 10 kV overhead line and began installing 7 reinforced concrete poles, followed by installation of self-supporting insulated wire. The new power transmission line will be equipped with modern distribution equipment, complete with remote control devices.



#### Ryazan power engineers have begun repair work at the 110 kV substation "Likhachevo"

Employees will carry out current and overhaul repairs of main equipment, two power transformers, 57 disconnectors, 4 oil switches and 5 SF6 gas switches, reports the Informationbureau telegram channel. The specialists are carrying out work to prepare the electric grid complex for the upcoming heating season. It is scheduled for completion in September 2024.
