#### **Decision:**

1. In order to efficiently and reliably operate facilities of the distribution power grid complex of the Kursk region to preliminarily approve the merger of the following Distribution Zones of the branch of IDGC of Centre, PJSC - Kurskenergo in accordance with the Roadmap (Appendix # 1 to this decision of the Reliability Committee):

- Zolotukhinsky and Ponyrovsky united Zolotukhinsky Distribution Zone;
- Kursky and Central united Kursky Distribution Zone;
- Kurchatovsky and Oktyabrsky united Kurchatovsky Distribution Zone.

2. In order to efficiently and reliably operate facilities of the distribution power grid complex of the Lipetsk region to preliminarily approve the merger of the following Distribution Zones of the branch of IDGC of Centre, PJSC - Lipetskenergo in accordance with the Roadmap (Appendix # 2 to this decision of the Reliability Committee:

- Zadonsky and Khlevensky united Zadonsky Distribution Zone;

- Sverdlovsky, Maloarkhangelsky and Glazunovsky united Glazunovsky Distribution Zone;
- Novosilsky and Zalegoschensky united Novosilsky Distribution Zone;
- Uritsky, Soskovsky and Shablykinsky united Uritsky Distribution Zone;
- Kromskoy, Trosnyansky and Dmitrovsky united Kromskoy Distribution Zone;
- Bolkhovsky, Khotynetsky and Znamensky united Bolkhovsky Distribution Zone.

4. In order to efficiently and reliably operate facilities of the distribution power grid complex of the Bryansk region to preliminarily approve the merger of the following Distribution Zones of the branch of IDGC of Centre, PJSC - Bryanskenergo in accordance with the Roadmap (Appendix # 4 to this decision of the Reliability Committee):

- Gordeevsky, Krasnogorsky and Klintsovsky united Klintsovsky Distribution Zone;
- Zlynkovsky and Novozybkovsky united Novozybkovsky Distribution Zone;
- Rognedinsky and Dubrovsky united Dubrovsky Distribution Zone;
- Bryansky and Zhiryatinsky united Bryansky Distribution Zone;
- Sevsky and Suzemsky united Sevsky Distribution Zone.

5. In order to efficiently and reliably operate facilities of the distribution power grid complex of the Voronezh region to preliminarily approve the merger of the following Distribution Zones of the branch of IDGC of Centre, PJSC - Voronezhenergo in accordance with the Roadmap (Appendix # 5 to this decision of the Reliability Committee):

- Khokholsky and Voronezhsky – united Khokholsky Distribution Zone.

6. In order to efficiently and reliably operate facilities of the distribution power grid complex of the Kostroma region to preliminarily approve the merger of the following Distribution Zones of the branch of IDGC of Centre, PJSC - Kostromaenergo in accordance with the Roadmap (Appendix # 6 to this decision of the Reliability Committee):

- Buisky and Susaninsky united Buisky Distribution Zone;
- Vokhomsky, Pavinsky and Oktyabrsky united Vokhomsky Distribution Zone;
- Kostromsky and Gorodsky united Kostromsky Distribution Zone;
- Manturovsky and Mezhevsky united Manturovsky Distribution Zone;
- Nerekhtsky and Volgorechensky united Nerekhtsky Distribution Zone;
- Sharyinsky, Ponazyrevsky and Rozhdestvensky united Sharyinsky Distribution Zone.

7. In order to efficiently and reliably operate facilities of the distribution power grid complex of the Tambov region to preliminarily approve the merger of the following Distribution Zones of the branch of IDGC of Centre, PJSC - Tambovenergo in accordance with the Roadmap (Appendix # 7 to this decision of the Reliability Committee):

– Kirsanovsky and Gavrilovsky – united Kirsanovsky Distribution Zone.

8. In order to efficiently and reliably operate facilities of the distribution power grid complex of the Yaroslavl region to preliminarily approve the merger of the following Distribution Zones of the

branch of IDGC of Centre, PJSC - Yarenergo in accordance with the Roadmap (Appendix # 8 to this decision of the Reliability Committee):

– Lyubimsky, Danilovsky and Pervomaisky – united North-East Distribution Zone.

9. To recommend that General Director of the Company hold organizational measures to integrate these Distribution Zones in accordance with the Roadmaps.
