### The united company FGC-Rosseti received the status of a strategic one

Russian President Vladimir Putin signed a decree on granting the status of a strategic company to the united company FGC-Rosseti, according to a document published on the portal of legal information. The Rosseti company and its subsidiary Federal Grid Company, which manages transmission power grids, announced the merger in mid-July 2022. Each of the companies before the reorganization was strategic. After the reorganization, the direct share of the Russian Federation in the authorized capital of the united company FGC-Rosseti amounted to 75.000048%. The merged company became the sole operator of both the transmission and distribution complex in Russia.

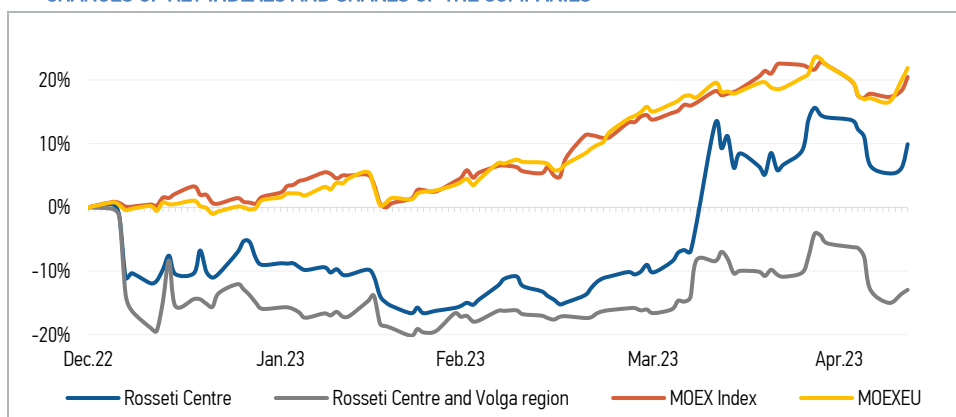
