**Russian Railways sells at auction 49% of its power grid subsidiary, the declared price is RUB 968 million**

Energopromsbyt is a daughter of Russian Railways, the monopoly owns 51% of the authorized capital. The main activity of Energopromsbyt is connection of third-party consumers to power grids of Russian Railways, as well as the connection of Russian Railways to the power grids of other grid companies. Previously, the company owned a large stake in TGC-14 (39.81%), which, together with a stake in NPF Blagosostoyanie (more than 52%, a total of 92.2% of shares), was sold at the beginning of the year to Far Eastern Management Company of the former head of TGC-14 Victor Myasnik.

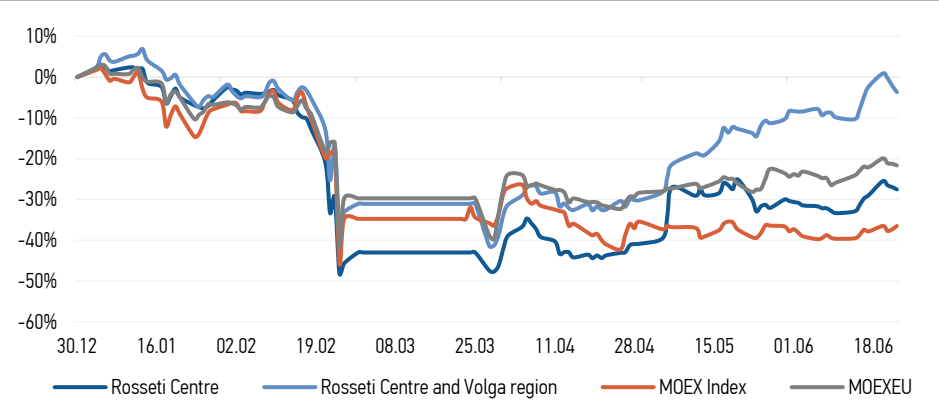
