

Tulenergo cleared routes and expanded ROWs of power lines on an area of more than 400 hectares

In accordance with the repair program in Rosseti Centre and Volga region – Tulenergo, work continues on clearing routes and expanding ROWs of overhead power lines of 0.4–110 kV. Since the beginning of the year, 361 ha of overhead power lines have been cleared of trees and shrubs, and 40 ha of ROWs along overhead power lines have been expanded. Until the end of the year, it is planned to carry out the work on another 607 hectares.
