#### **REVIEW OF STOCK MARKETS**

IDGC OF CENTRE

Before the opening of trading some moderately negative external background formed on the Russian market on October 14. Last Friday, the major U.S. indices ended with the growth of 0.6-0.8% on the optimistic statements by U.S. politicians on the constructive nature of the negotiations on budget issues and the national debt ceiling. At the same time, the Asia Pacific MSCI index, excluding Japan resting on Monday, declined by 0.3%, and the U.S. futures were losing more than half a percent. The reasons for the sales were, firstly, not realized hopes for resolution of the budget crisis in the U.S. – according to media reports, the White House rejected the Republican proposal to raise the ceiling on borrowing for a minimum of six weeks, secondly, weak data from China, where September data on exports and inflation were worse than expected. December Brent was trading around \$110.5 per barrel, at the level of our closing on Friday.

Most of the trading session on Monday, Russian and European indices were under pressure from the U.S. problems and the Chinese statistics, had a small loss, on average, about half a percent. Some support to the markets by limiting the activity of sellers was given by the released better than analysts' forecasts report on industrial production in the Eurozone in August. At the end of the day, the Russian indices were able to play back half of the day's losses after not as negative as this was indicated by the dynamics of futures start of trading in the United States.

According to the results of the trades, the MICEX Index lost 0.19% to close trading at 1,510.20 points and the RTS Index fell by 0.21% to close at 1,473.97 points. The MicexPWR Sector Index decreased by 0.06%, reaching 1,077.64 points. On Western exchanges the European DJStoxx 600 Index rose by 0.2%, and the American S&P 500 Index went another 0.41% up.


