Tverenergo improves the reliability of 6-10 kV overhead lines

The branch of Rosseti Centre - Tverenergo continues implementing a set of measures aimed at improving the quality and reliability of power supply. Work on overhead lines of the 6-10 kV distribution grid is carried out in all Distribution Zones. Since the beginning of 2023, Tverenergo's specialists have completed the replacement and stretching of 98 km of wire, straightened and replaced 215 overhead lines and upgraded 147 insulators on them. The power engineers also replaced and installed 14 line disconnectors.

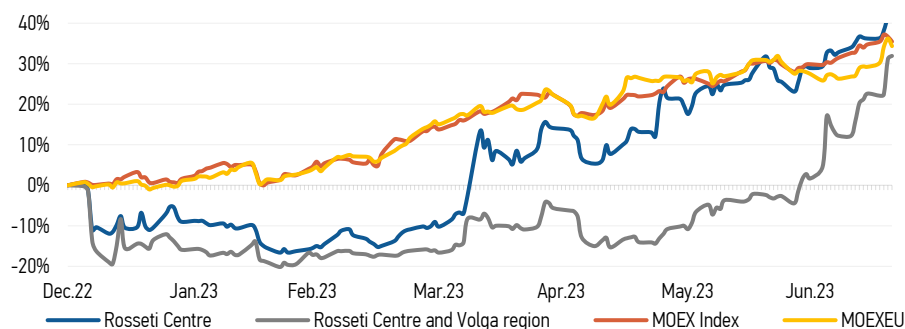
