Item 6. On approval of the agreement for removal of restrictions on the use of a land plot, concluded between IDGC of Centre (IDGC of Centre - Yarenergo division) and OJSC «YarEGC», which is a related party transaction.

Decision:

1. To determine that the estimated cost of services for the removal of restrictions on the use of a land plot under the agreement, concluded between IDGC of Centre (IDGC of Centre - Yarenergo division) and OJSC «YarEGC», is 482 346,06 (Four hundred and eighty-two thousand three hundred and forty six) rubles 06 kopecks, VAT inclusive (18%) 73 578,21 (Seventy three thousand five hundred seventy-eight) rubles 21 kopeks and determined based on the estimate calculation (Appendix 3 to the Agreement) and the signed by both parties certificate on fulfillment of obligations.

2. To approve the service agreement for the removal of restrictions on the use of a land plot, concluded between IDGC of Centre (IDGC of Centre - Yarenergo division) and OJSC «YarEGC», which is a related party transaction, on the following essential conditions:

Parties of the agreement:

«Customer» - OJSC «YarEGC»;

«Contractor» - IDGC of Centre (IDGC of Centre - Yarenergo division).

Subject of the agreement:

Owner is obliged to take in the period from the date of signing the agreement within 15 days all necessary measures on the removal from the land plot belonging to him of overhead power line Conductor-10kV №01 (from pole №10 to pole №14, inventory number 3004060), and Applicant agrees to indemnify Owner incurred costs in connection with the execution of item 1.2 of the Agreement.

Price of the agreement:

Approximate volume of expenses required for the execution by Owner of item 1.2 of the Agreement amounts to 482 346,06 (Four hundred and eighty-two thousand three hundred and forty six) rubles 06 kopecks VAT inclusive (18%) 73 578,21 (Seventy three thousand five hundred seventy-eight) rubles 21 kopeks and is determined in accordance with Appendix 3 to the Agreement.

Turnaround time:

Within 15 (fifteen) days from the date of signature of the Agreement.

Duration of the agreement:

The Agreement is valid from the date of signing of the agreement until the parties fulfill their obligations.

Dispute resolution:

All disputes, controversies and claims arising from the Agreement, or in connection with it, including related to its conclusion, alteration, execution, violation, termination, and validity, are to be settled in the Arbitration Court of Yaroslavl region.

Before contacting the Arbitration Court of the Yaroslavl region for the resolution of the dispute, the Parties undertake to observe the claim procedure for dispute settlement. Time for consideration of claims is 15 (Fifteen) calendar days from the date of the claim.

Other provisions recognized as essential by the Parties:

In case of untimely fulfillment of obligations on payment under Section 2 of the Agreement

Owner shall be entitled to recover from the applicant the penalty of 0.1% (one tenth percent) of the unpaid amount for each day of delay until the date of actual payment.

Item 7. On approval of the agreement to perform emergency and restoration operations, concluded between IDGC of Centre and IDGC of Centre and Volga Region, which is a related party transaction.

Decision:

1. To determine in accordance with the planned scope of work specified in the budget documentation (Appendix #1 to the Agreement) the cost of emergency and restoration operations to eliminate consequences of failures at facilities of IDGC of Volga - Penzaenergo in the amount of 1 147 521 (One million one hundred forty-seven thousand five hundred twenty-one) rubles 75 kopecks, VAT inclusive (18%) in the amount of 175 045 (One hundred seventy-five thousand and forty-five) rubles 69 kopecks.
2. To approve the agreement to perform emergency and restoration operations to eliminate consequences of failures at facilities of IDGC of Volga - Penzaenergo, caused by damage to equipment as a result of natural disasters, concluded between IDGC of Centre and IDGC of Volga, which is a related party transaction, on the following essential conditions:

Parties of the agreement:

«Customer» - IDGC of Volga;

«Contractor» - IDGC of Centre.

Subject of the agreement:

Contractor undertakes to perform emergency and restoration operations to eliminate consequences of failures at the facilities (Appendix #2 to the agreement) of Customer, caused by damage to equipment as a result of natural disasters, and pass the result of work to Customer, and Customer agrees to accept the result of work and pay for it in the manner prescribed by the agreement. Types of work, their content and scope are determined by the parties in the Estimates (Appendix # 1 to the agreement). The concept (definition) of the failure is understood in the sense in which it is treated in the Rules to investigate causes of failures in the electric power industry approved by the RF Government Decree of October 28, 2009 № 846.

The Parties in their activities are guided by the laws and other regulations of the Russian

Federation governing the organization and functioning of the wholesale and retail electricity markets, and the Agreement.

Representative of Customer under the agreement is IDGC of Volga - Penzaenergo provided with the following powers: to sign the estimates, receipt and inspection of work performed under the form KS-2, information on the cost of the work performed and costs under the form KS-3, certificates of transfer of the Equipment for installation at the facility, certificates of reconciliation of mutual settlements; to receive bills, invoices; to make reconciliation netting.

Price of the agreement:

The cost of work of Contractor performed is 1 147 521 (One million one hundred forty-seven thousand five hundred twenty-one) rubles 75 kopecks, VAT inclusive (18%) in the amount of 175 045 (One hundred seventy-five thousand and forty-five) rubles 69 kopecks, in accordance with the planned scope of work specified in the budget documentation (Appendix # 4 to this Agreement).

Turnaround time:

Turnaround time, terms of separate stages of work under the Agreement, preparation by Contractor of work for receipt - acceptance by Customer are determined in accordance with the Work schedule (Appendix # 3 to the agreement).

Turnaround time is from «03» February 2015 to «05» February 2015.

Duration of the agreement:

The Agreement shall enter into force upon the signature, cover the legal relationship of the parties, in fact, occurred from 03 February 2015 and is valid until the Parties fulfill all their obligations under the Agreement.

Item 8. On approval of Agreements of temporary limited use of an overhead power line, concluded between IDGC of Centre and OJSC «FOCL-Conductor Administration», which is a related party transaction.

Decision:

1.1. To determine in accordance with the Evaluation report of the independent appraiser LLC «LAIR» №H-16596/13 the monthly cost of providing to the User the right for

temporary limited use of an overhead power line in the period of use (payment) in the amount of 5 861,50 (Five thousand eight hundred sixty-one) rubles 50 kopecks, including VAT (18%) 894,13 (Eight hundred ninety four) rubles 13 kopecks.

1.2. To approve the agreement of temporary limited use of an overhead power line, concluded between IDGC of Centre and OJSC «FOCL-Conductor Administration», which is a related party transaction, on the following essential conditions:

Parties of the Agreement:

Owner - IDGC of Centre

User - OJSC «FOCL-Conductor Administration»

Subject of the Agreement:

Owner under the terms of the Agreement provides to User for a fee for the term of use the right of temporary (limited) use of the property used for the purpose of installation of fiber-optic communication line (FOCL) and operating Shares in FOCL of User.

Used equipment is provided under the Act of used property, which is Appendix # 2 to the Agreement and shall be signed on the date of signature of the Agreement.

Equipment belonging to Owner under the right of ownership and provided by him for temporary limited use to User in the manner and under the terms of the Agreement (the used equipment) – it is the construction of the Electric Grid Facility «N.P.S. - Andreapol - Sinkovo – Bologovo», the facility address: Tver region, Andreapolsky, Nelidovsky, Zapadnodvinsky districts, city of Andreapol, belonging to Owner under the right of ownership (Certificate of state registration of the right Series 69-AB № 180241 of 13.05.2008; cadastral (or conditional) number: 69:00 000000 0037 4/2/01/ 1001/A).

User is provided with the right to use metal structures (cross-arms, lightning conductor mounting frames) of the poles specified below of the Used equipment in all their length, i.e. in 28 385 metres (from the Portal Andreapol to the Portal Erokhino).

Price of the Agreement:

The monthly cost of the provided to the User rights under the Agreement for the period of use (payment) is 5 861,50 (Five thousand eight hundred sixty-one) rubles 50 kopecks, including VAT (18%) 894,13 (Eight hundred ninety four) rubles 13 kopecks.

The cost is determined on the basis of the Evaluation report №H-16596/13, performed by the independent appraiser LLC «LAIR».

The fee is charged on a monthly basis in equal installments from the date of signing by the parties of the Act of provision of the Used equipment.

Payment under the Agreement is made by transfer the following property (hereinafter - «the Property») to Owner: The share of FOCL in the amount of 16.67%, namely 8 Optical Fibres and 16.67% in the common ownership of the totality of the other FOCL elements providing mechanical protection of transferred Optical Fibres from external influences, their placement and use, in particular, a metal braid (containment), power components, optical modules, hydrophobic gels, connectors and splices, optical crosses, as well as fittings required for installation (suspension) of FOCL.

The Property is located on overhead power lines and electric power facilities, namely: the Electric Grid Facility 110kV «Nelidovo - Rzhev - Staritsa - Rear field with substations 110kV», purpose: energy and power transmission structures, the facility address: Tver region, Nelidovsky, Staritsky, Oleninsky, Rzhevsky districts (cadastral number: 69:00:000000:0012:422/44/22/23/27/46/09/32) in the section Substation Andreapol – Substation Erokhino.

The cost of the Property transferred to Owner under the Agreement is 1 758 450,00 (One million seven hundred fifty-eight thousand four hundred and fifty) rubles 00 kopecks, VAT inclusive (18%) 268 238,14 (Two hundred sixty-eight thousand two hundred thirty-eight) rubles 14 kopecks.

Term of use:

Owner provides to User the right of temporary (limited) use of the used property for a period (period of use) of 25 (twenty five) years from the date of signing the Certificate of provision of the used property (Appendix # 2).

At the end of the period of use in case the Term of use is not extended in accordance with paragraph 6.3 of the Agreement, User agrees to stop using the Used property, which must be confirmed by the relevant certificate.

State registration of encumbrance:

User will bear all the costs, 1) associated with the state registration of temporary limited use in the bodies carrying out state registration of rights to immovable property and transactions with them, 2) that may arise during the implementation of state registration of temporary restricted use associated with the development and registration of measurements, diagrams, cadastral plans and other documents necessary for state registration of temporary limited use of the used property, 3) associated with changes in constitutive and operational documents for the used equipment, which may arise in connection with the execution of the Agreement.

Duration of the agreement:

The Agreement shall enter into force from the moment of its signing and cover legal relations of the Parties, in fact, arisen from 01.01.2014.
