### The State Duma adopted a law on abolition of benefits for connection to power grids

The State Duma adopted in the third, final reading a law that involves adjusting the mechanism for a new connection with a gradual transition to full compensation of costs to grid companies for the implementation of grid connection of applicants with power installations with a capacity of up to 150 kW. The law, initiated by the government of the Russian Federation, amends the law "On the Electric Power Industry".

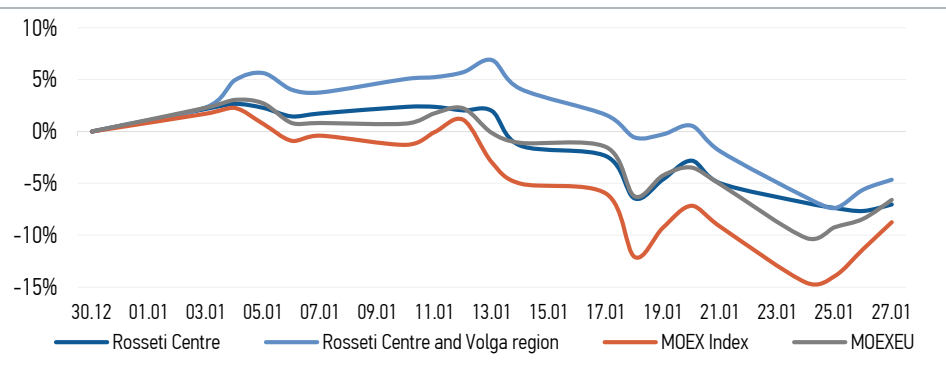

### Tulenergo repaired almost 4,000 kilometres of power lines in 2021
