The information about the termination of the activities of Public Joint Stock Company Russian Grids, as well as Joint Stock Companies Kuban Transmission Grids, Tomsk Transmission Grids, Far Eastern Energy Management Company - UNEG, from 9 January 2023 in connection with their merger to Public Joint Stock Company Federal Grid Company - Rosseti (PJSC Rosseti, United Company Rosseti, formerly PJSC FGC UES) was entered into the Unified State Register of Legal Entities.


