2.10. If income on the issuer's securities has not been paid or not paid by the issuer in full, the reasons for non-payment of the income on the issuer's securities:

**The obligation to pay dividends on the issuer's shares is complete with the exception of cases in which the issuer is not liable in accordance with paragraph 16 of Article 8.2 of Federal Law dated 22.04.1996 № 39-FZ "On the Securities Market": the dividends were not paid to those shareholders, who did not provide the keeper of the register of shareholders or a depository information about changes of their data. The total amount of unpaid dividends for these reasons as of 18.07.2018 is 6 983,56 thous. RUB or 0,79% of the total accrued dividends. Payment of this debt on dividends will be made upon receipt of details for the debt payment and requests of shareholders demanding the payment.**
