#### FGC's shareholders approved the merger of Rosseti and other structures with the company

The shareholders of PJSC FGC UES at an extraordinary meeting on Wednesday, 14 September, approved the merger of PJSC Rosseti and other grid structures with the company. Based on the voting results, the maximum amount of the company's expenses for the buyback of shares, which accompanies the reorganization procedure according to the law on JSCs, may amount to a little more than RUB 20 billion. According to the company, 28,107,858,553 votes were cast against the reorganization, which corresponds to 2.63% of the total number of votes of the meeting participants. 0.1631% abstained from voting (1,742,890,035 votes). 707,938 persons did not vote.

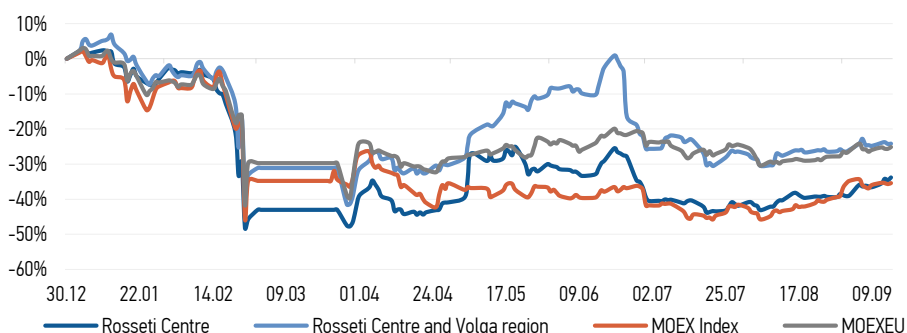
