The term (procedure for determining the term) of redemption of bonds or options of the issuer or information that the redemption period of bonds is not determined (for bonds without a redemption date): The Bonds are redeemed on 1 260 (One thousand two hundred and sixtieth) day from the date of commencement of placement of the Bonds.</p> <p>2.3.
