Ministry of Energy of the Russian Federation revises regulations on security of fuel and energy facilities

The State Duma has already adopted in the first reading a bill that allows fuel and energy companies to establish "corporate" private security organizations. "At the same time, the composition of organizations that will be able to protect facilities of the fuel and energy complex is being specified, depending on the hazard category of such facilities," explained the director of the department of economic security in the fuel and energy complex.
