Rosseti to place an additional issue for ₽120.5 billion in favour of the state to receive assets in regions

The shareholders of Rosseti at the annual general meeting on 30 June agreed to increase the company's authorized capital in order to receive regional assets from the state. It is about the placement of 240 billion 890 million 189 thousand 234 additional ordinary shares at their nominal value of RUB 0.5, that is, the total volume of the additional issue will be RUB 120.5 billion.


The season of student teams started in branches of Rosseti Centre and Rosseti Centre and Volga region
