Profit of Rosseti increased by 10% in 2022 - Ryumin

Profit of Rosseti in 2022 increased by 10%, the company's CEO Andrey Ryumin said at a meeting with Russian Prime Minister Mikhail Mishustin, which took place on 14 March.

"In terms of financial indicators, both for the transmission and distribution complex, we see growth. In particular, net profit [at the end of 2022] increased by approximately 10%," he said.

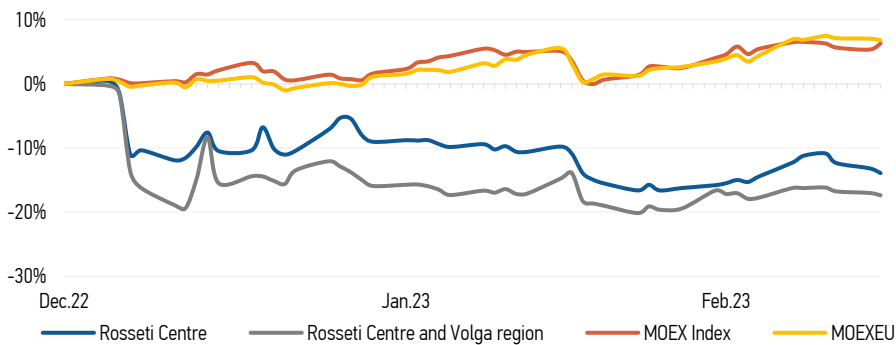
The Ryazanenergo branch invites consumers to the next "Customer Day"
