Shevchuk, was received on this item: I draw your attention that the said money was not included in the Company's Business Plan and the implementation of paragraph 2, in principle, is impossible. This type of charity (the transfer of funds to Non-profit foundation to promote the study of public opinion WCIOM in the amount of 80 million rubles) does not correspond either to the basic objectives of the Company, or the social policy of the company. There is no justification of the need for the proposed aid, information about the initiator of consideration of this issue is also absent. It should be noted in the Company there is an unregulated order of charity provision and contracting of sponsorship, including FC CSKA, which ultimately leads to unjustified costs for the Company.
