 - 2.5. Explanation of expenses under items 2.7. "Miscellaneous inputs" and 8 "Miscellaneous charges" of the Forecasting Plan of IDGC of Centre's activities results for 2009.
- 3. It was decided to forward the materials submitted for JSC "IDGC Holding" consideration, simultaneously to members of the Strategy and Development Committee within the time not later than 2 February 2009.
