Rosseti and FGC-Rosseti bought shares for RUB 1.4 billion from those who disagreed with the reorganization

Rosseti and FGC-Rosseti bought shares from those who disagreed with the reorganization for a total of RUB 1.4 billion, follows from the message of the companies.

In particular, it is indicated that Rosseti bought out 1,120,914,129 ordinary shares (0.55794% of the authorized capital) and 282,993,375 preferred shares (0.14086%) of the authorized capital. The number of voting shares acquired by FGC-Rosseti amounted to 3,948,324,973 pieces (0.30975% of the authorized capital).


