### Interaction of entities in terms of the technological functioning of the electric power industry to be simplified in Russia

According to the press service of the Russian Ministry of Energy, yesterday the State Duma of the Russian Federation in the first reading approved a draft law on amendments to the Federal Law "On the Electricity Industry", which simplifies the interaction of entities in terms of the technological functioning of the electric power industry. According to Deputy Minister of Energy of Russia Anastasia Bondarenko, who presented this bill to the State Duma of the Russian Federation, the bill is supposed to exclude non-functioning regulation mechanisms in the electric power industry.


