The Ministry of Energy to submit to the State Duma in the autumn a draft allowing the construction of direct-flow power plants

The Ministry of Energy of the Russian Federation expects to submit to the State Duma in the autumn a bill excluding from clause 4 of Article 60 of the Water Code a ban on the design of direct-flow technical water supply systems for thermal and nuclear power facilities. It was reported by "Rossiyskaya Gazeta".


