Ministry of Finance: "New dividend rules for state-owned companies do not apply to Rosseti"

Rosseti will continue to be guided in the payment of dividends by special government order 1094-r, the new general rule for state-owned companies does not apply to the holding, the Ministry of Finance and the company told Interfax in response to a request. "There is a special order for them, they will pay in the same way - under 1094-r," the ministry's press service noted. The company gave a similar comment, recalling that this order also applies to the position of the controlling shareholder regarding payments of subsidiaries of Rosseti.


