Market Council fears double payments to waste power plants

According to Kommersant's information, Market Council proposes to revise the calculation of payments for capacity for waste incineration power plants (WIPP) of Rostec. According to the regulator, the main revenue of WIPPs should consist of income from waste incineration, and not payments from the energy market, which should already amount to about 18 billion rubles a year. Rostec believes that such an approach will lead to an increase in the tariffs of the population for garbage disposal by 400%.


